Business Solo offer terms and conditions

1. Customers signing up to an 18 month Business Solo talkplan can choose **one** of the above benefits to add to their service plan.
2. Customers signing up to a 24 month Business Solo talkplan can choose **two** benefits to add to their service plan.
3. The offer is only available to new customers or existing customers who resign between 11th January 2010 and 31st March 2010 (the 'Offer Period').
4. Customers who already have a 24 month Business Solo contract are not able to have a second benefit added unless they resign during the Offer Period.
5. **Unlimited landline** subject at all times to a fair usage policy of 3,000 minutes each month. Unlimited landline is for calls in the UK to UK landline 01, 02 and 03 numbers only.
6. **Unlimited text** is subject at all times to a fair usage policy of 3,000 texts each month. Unlimited text is for standard person to person texts within the UK only.
7. **Unlimited Orange to Orange** is subject to a fair usage policy of 3,000 minutes each month. Unlimited Orange to Orange means calls made from within the UK to other Orange mobiles within the UK. Calls made whilst roaming are not included. Orange numbers that receive a call whilst roaming would be charged standard roaming rates.
8. **Unlimited Email** is BlackBerry Internet Service (BIS) and includes Orange's standard BIS with Talk product, which is subject to a fair use policy in respect of the unlimited data use, and other terms and conditions. These are set out at www.orange.co.uk/business/BIS.
